Navigation Basics



This Quick Reference Guide (QRG) is designed to provide Beverage Suppliers or First Responsible Suppliers a step-by-step guide on the use of the Product Registration & Beverage Supplier portal.

The Product Registration & Beverage Supplier portal is where containers can be registered to be available for the 10 cent refund in the scheme. It is also where the Beverage Suppliers declare their monthly sales volumes per material type.



HOW TO USE THIS QUICK REFERENCE GUIDE

- It is suggested to use the flow that is built into this guide to ensure you go through all the Product Registration & Beverage Supplier portal screens.
- Move back and forth between slides by using the arrows.
- The menu bar is embedded in all the slides to facilitate navigation within this presentation.





PRODUCTS

Containers must be registered under the scheme to be eligible for the 10-cent refund

- Beverage Suppliers can register their eligible containers in their own name (as opposed to WARRRL's) through the portal
- It must go through an approval process with the Department of Waste and Environmental Regulation (DWER)
- Only when the container details are approved, can the containers be eligible for 10-cent refund and searchable on public product register.
- There are two ways to register a product:
 - Manual product registration
 - Bulk upload products






- The fields have hints to help the user enter applicable information.




Beverage Supplier Sales Volumes declaration

- In accordance with the legislation, a Beverage Supplier must declare their historical sales volumes in order to contribute to the Scheme costs.
- These are monthly declarations and must be submitted in the Portal before the 15th of the month, otherwise it will show as overdue and an invoice will be generated based upon estimated data.






