


Total weight of material types collected and delivered for recycling under the CDS redeemed through refund points (excluding MRFs) listed by material types.

Total weight of material types collected and delivered for recycling under the CDS, listed by material types and redeemed through MRFs (excluding refund points)






MRF tonnes are converted into container volumes using the state-wide eligible container factor which make up the MRF eligible claims against the Scheme.
