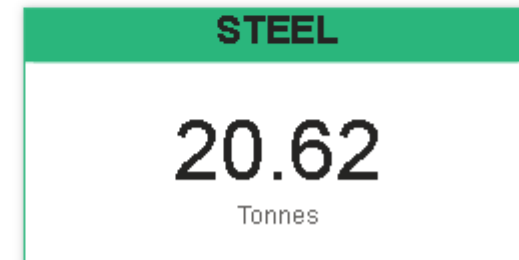

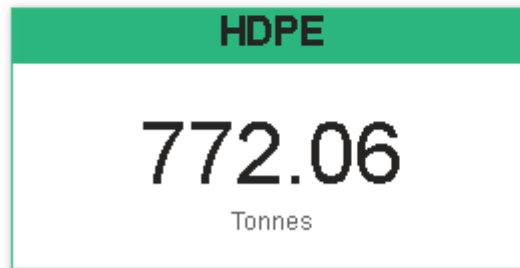

Total weight of material types collected and delivered for recycling under the CDS redeemed through refund points (excluding MRFs) listed by material types.



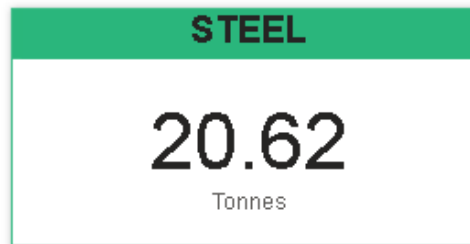
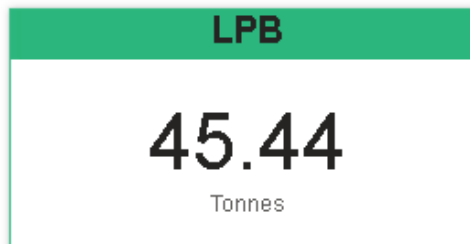
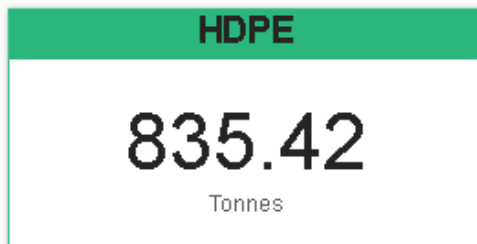
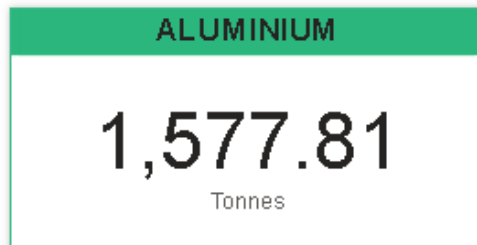
